

BFD MEMBERSHIP FORM

The membership period of the **BFD (Brew Free or Die)** Homebrewing Club shall be the calendar year. Dues are \$20 for an Individual Membership or \$25 per year for a Couple Membership (an individual plus a spouse/significant other). By signing this form and paying dues to **BFD**, the undersigned hereby applies for membership in the Club and agrees to the following terms and conditions of membership:

1. I will comply with the By-Laws, other published rules and regulations, and club policies. I will cooperate with other members to promote the activities and mission of **BFD**.
2. I understand this Application is limited to the named applicant(s) and does not extend to any other individual or affiliate of the applicant. Note: Spouses and invited guests of members in good standing are always welcome at club functions.
3. I understand that participation in club activities may involve the production and/or consumption of alcoholic beverages, and said consumption may inhibit my ability to make rational decisions. I accept sole responsibility for my conduct, behavior, and actions at any club meetings or activities as well as any consequences that may occur as a result of said conduct, behavior, and actions.
4. I indemnify, release, and hold harmless **BFD**, its officers, volunteers, and individual members of any responsibility for my conduct, behavior, and actions at any club meetings or activities. This indemnification specifically includes any property damage or injury I may cause to myself or others. I waive any ability to challenge **BFD**, its officers, and individual members regarding any liability for acts or omissions alleged in the preparation of this document. This release shall bind all my heirs, successors, and assigns. I further agree that this indemnification applies to any of my spouses/significant others, children, or wards in connection with **BFD** club meetings or activities.

This membership form is governed by the laws of New Hampshire and, as such, it will be construed as broadly as permitted by the laws of New Hampshire. It will have full force and effect through publication to our website or any form of social media. Any violation of the conditions listed above may result in termination of membership for the individual and spouse/significant other. If any portion of this document is found by a court of law or similarly situated arbitrator to be not enforceable or valid, the remaining portions shall remain in full force and effect.
